## **Limited Warranty for PV Modules -2020**

**Thank you for purchasing Kingdom Solar module**

### **1. Limited Product Warranty**

Ten Years Repair Zhejiang Kingdom Solar Energy Technic Co.,LTD warrants its Photovoltaic Solar Modules (MODULES), including factory-assembled DC connectors and cables, if any, to be free from defect in materials and workmanship under normal application, use and service conditions. If MODULES fail to conform to this warranty, during the period ending One hundred and twenty (120) months from the date of sale as shown in the invoice to the first consumer customer of the Kingdom Solar product (CUSTOMER), Kingdom Solar will repair the product. The repair or replacement or refund remedy shall be the sole and exclusive remedy provided under the "Limited Product Warranty" and shall not extend beyond the One hundred and twenty (120) months period set forth herein. This "Limited Product Warranty" does not warrant a specific power output, which shall be exclusively covered under clause 2 hereinafter ("Limited Peak Power Warranty").

### **2. Limited Peak Power Warranty -Limited Remedy**

10 years If, within a period of ten (10) years from the date shown in the invoice to the CUSTOMER any MODULE(s) exhibits a power output less than 90 % of the Minimum "Peak Power at STC" as specified at the date of invoice in Kingdom Solar "s Product Information Sheet, provided that such loss in power is determined by Kingdom Solar ( at its sole and absolute discretion ) to be due to defects in material or workmanship, kingdom Solar will replace such loss in power by either providing additional MODULES to the CUSTOMER to make up for such loss in power, or by replacing the defective MODULE(s) at the option of Kingdom Solar. 25 years If, within a period of twenty-five (25) years from the date shown in the invoice to the CUSTOMER any MODULE(s) with a Nominal Power of at least exhibits a power output less than 80% of the minimum "Peak Power at

STC"as specified at the date of invoice in Kingdom Solar' s Product Information Sheet, provided that such loss in power is determined by Kingdom Solar (at its sole and absolute discretion) to be due to defects in material or workmanship, Kingdom Solar will add MODULES to the CUSTOMER to make up for loss in power, at the option of Kingdom Solar. The remedies set forth in this clause 2 shall be the sole and exclusive remedies provided under the "Limited Peak Power Warranty".

### **3. Exclusions and Limitations**

(1) In any event, all warranty claims must be filed within the applicable warranty period. (2) The "Limited Product Warranties" and the "Limited Peak Power Warranties" do not apply to any MODULES which have been subjected to: Misuse abuse, neglect or accident; Alteration, improper installation or application; Non-observance of Kingdom Solar's installation and maintenance instructions; Repair or modifications by someone other than an approved service technician of Kingdom Solar; Power failure surges, lighting, flood, fire, accidental breakage or other events outside Kingdom Solar' control. (3) Both, the "Limited Product Warranties" and "Limited Peak Power Warranties" do not cover any transportation charge, customs clearance or any other costs for return of the MODULES, or for reshipment of any repaired or replaced MODULES, or costs associated with installation, removal or reinstallation of the PV-modules. (4) Warranty claims will not be honored if the type or serial number of the MODULES has been altered, removed or made illegible. (5) This "Limited Warranty for PV Modules" does not apply to MODULES marked as "Grade A" or "Grade B". Kingdom Solar explicitly refers to their "Limited Warranty for PV Modules marked Grade A", their "Special Limited Warranty for PV Modules marked Grade B" reflecting these categorized modules.

### **4. Limitation of Warranty Scope**

### ***Limited Warranty for PV Modules -2020***

These "Limited Warranties for PV Modules" as set forth herein are expressly in lieu of and exclude all other express or implied warranties, including but not limited to warranties of merchantability and of fitness for particular purpose, use, or application, and all other obligations or liabilities on the part of Kingdom Solar, unless such other obligations or liabilities are expressly agreed to in writing signed and approved by Kingdom Solar. Kingdom Solar shall have no responsibility or liability whatsoever for damage or injury to persons or property, or for other loss or injury resulting from any cause whatsoever arising out of or related to the MODULES, including, without limitation, any defects in the MODULE, or from use or installation. Under no circumstances shall Kingdom Solar be liable for incidental, consequential or special damages, howsoever caused. Loss of use, loss of profits, loss of production, and loss of revenues are specifically and without limitation excluded. Kingdom Solar's aggregate liability, if any, in damages or otherwise, shall not exceed the invoice value as paid by the CUSTOMER, for the single unit of MODULE.

#### 5. Obtaining Warranty Performance

If the CUSTOMER feels a justified claim covered by this "Limited Warranties for PV Modules", an immediate notification directly to Kingdom Solar shall be filed by mailing a [registered/certified] letter in writing to the address of Kingdom Solar listed here-under, or, sending an email letter to the email account of Kingdom Solar listed here-under. Together with the notification, the CUSTOMER should enclose the evidence of the claim with the corresponding serial number of the MODULE(s) and the invoice on which the MODULES have been purchased.

#### 6. Severability

If a part, provision or clause of this "Limited Warranty for PV Modules", or the application thereof to any person or circumstance, is held invalid, void or unenforceable, such

holding shall not affect and shall leave all other parts, provisions, clauses or applications of this "Limited Warranty for PV Modules", and to this end such other parts, provisions, clauses or applications of this "Limited Warranty for PV Modules" shall be treated as severable.

#### 7. Disputes

In case of any discrepancy in a warranty-claim, the third party test lab shall be involved to judge the claim finally. All fees and expenses shall be born by the losing party.

#### 8. Various

The repair or replacement of the MODULES or the supply of additional MODULES does not cause the beginning of new warranty terms, nor shall the original terms of this "Limited Warranty for PV-Modules" be extended. Kingdom Solar has the right to deliver another type (different in size, color, shape and/or power) in case Kingdom Solar discontinued producing the replaced MODULES at the time of the claim.

#### 9. Warranty Transfer

This warranty is transferable when the product remains installed in its original location at the warranty registration.

#### 10. Force Majeure

Kingdom Solar shall not be responsible or liable in any way to the customer or any third-party arising from any non-performance or delay in performance of any terms and

conditions of sale, including this "Limited Warranty for PV Modules", due to acts God, war, riots, strikes, warlike conditions, plague or other epidemics, fire, flood, or any other similar cause or circumstance beyond the reasonable control of such Kingdom Solar. In such cases, performance by Kingdom Solar of this Limited Warranty shall be suspended without liability for the period of delay

reasonably attributable to such causes.

### 11. Validity

This "Limited Power Warranty for PV Modules" is valid for 205w-390w MODULES dispatched between 1st January 2020 and 31st December 2020. 1 "Peak Power at STC" is the power in Watt peak that a PV-module generates in its Maximum Power Point. "STC" are as follows (a) Light spectrum of AM 1.5, (b) An irradiation of 1.000 W per square meter (c) A cell temperature of 25 degree centigrade at right angle irradiation. The measurements are carried out in accordance with TUV/IEC61215/61730/61701as tested at the connectors or junction box terminals - as applicable - per calibration and testing standards of Kingdom Solar valid at the date of Manufacture of the PV-modules.
